No. DPAR 5 SCR 2009, Bangalore, Dated : 17th August, 2009

Whereas the draft of the Karnataka Civil Services (Direct Recruitment by Competitive Examinations and Selections) (General) (Amendment) Rules, 2009 was published as required by clause (a) of sub-section (2) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 5 SCR 2009 dated 24th July 2009 and in Part IV-A of the Karnataka Gazette Extra-ordinary dated 25th July 2009 inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of publication of the draft in the Official Gazette.

Whereas, the said Gazette was made available to the public on 25th July 2009.

And whereas no objections and suggestions have been received by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby makes the following rules, namely :-

RULES

1. Title and Commencement :- (1) These rules may be called the Karnataka Civil Services (Direct Recruitment by Competitive Examinations and Selection) (General) (Amendment) Rules, 2009.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Amendment of Rule 6 :- In the Karnataka Civil Services Direct Recruitment by Competitive Examinations and Selection) (General) Rules, 2006 in rule 6,-

(i) In clause (A) in sub-clause (v) for the words "five times" the words "three times" shall be substituted; and

(ii) In clause (B), in sub-clause (iii) for the words "five times" the words "three times" shall be substituted.
